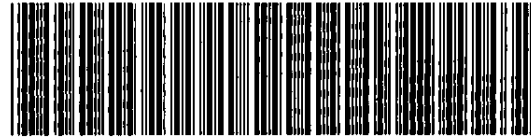

In our building we will provide a training center that teens and adults can enjoy. This will not only promote health and fitness in the community but will pull together respectable families to enjoy fun entertainment. We will give kids local heroes that they can cheer for, which could even be their own parents or siblings. Families will create memories that can lead to a long time of laughter and fun. We want to teach wrestling as a physical form of art. The ring is our canvas, so let us paint a picture.

Health and Fitness

Our physical activities are designed to motivate all members of the family to start a new and healthy lifestyle. Once families become active it will be easier to stay active and drop laziness from their daily lives. We will provide exercise equipment such as treadmills, elliptical machines, bikes, free weights, bench press, leg press, chest press, and a variety of other machines for teens and adults. For the younger children, we will have some outdoor activities to make sure they are getting a healthy amount of exercise each day. With funding, we hope to provide a jungle gym, pool, tetherball, basketball hoops, a skate park, and soccer nets.

Education

We realize that our youth's education is one of the most important aspects of their growth and that of this country. The first thing that any student will do, after arriving at our location, is spend time on school work. We will employ tutors to help with homework, test preparation, and any general problems students may be having with difficult subjects

Out reach

Giving back is also going to be an important part of our company. Once per week, we will host a wrestling show for the community at no charge to show our appreciation for all the support we receive. On the last week of every month we will have a special event show. The money that is raised from the event and merchandise sales will go to one of our select programs that will be named at the time of the event. We also plan to do more outreach activities, such as, sending letters and care packages to the soldiers that were sent overseas. Our youth will make visits to assisted living homes to spend time with the elderly as well. After the programs are more established, more outreach activities will be added.

At Risk Boys and Girls

Our teen's lives are being taken over by alcohol, drugs, sex, tobacco, violence, and gang involvement. This is causing our youth to drop out of school, accrue jail time, or just remain unemployed. They are being looked at as a burden and embarrassment to society. We plan to get these boys and girls back on the right track. Our facilities will give them a safe place to go hang out and have fun with other kids their age. Here at CWE we believe with consistent and sound messages, teens and young adults are capable of making a good decision to avoid these risk behaviors completely, especially if they are empowered by strong family and firm community connections. The physical activities will help them to relieve the aggression that would otherwise cause problems in their lives. What sets us aside from everyone else is our wrestling program. With this we can teach the youth about respect and protecting the person they are in the ring with. It takes a lot of discipline and responsibility and by instilling that in the youth they can use it in their lives. Who you are now, or what you've demonstrated up until now does not define who you will become.

Child Care

Children don't get enough time outside to play. Preschoolers and children need some unstructured physical activities and some structured activities.

At CWE we would have

- Teacher-led activities
- Outdoor play with open grassy areas and paved surfaces
- A wide variety of fixed play equipment (tether ball, jungle gyms etc.)
- Indoor play spaces
- Large variety of portable play equipment (balls, floor mats, jump ropes etc.)
- No virtual entertainment (for the exception of acceptable pre-approved music)
- Child focused learning
- Active play time shall not be withheld as punishment

Every mother is a "working" mom, but for mother's who go to school or work outside the home can create challenges and concerns. We can provide a free and safe environment with educational values. We want to help them be able to support their family.

Teen mothers are less likely to finish school. Juggling school and being a teenager is already difficult with
