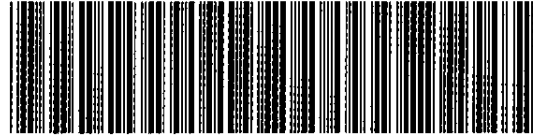

**ARTICLE I**

The name of the corporation shall be Suncoast Charger Baseball Boosters, Inc.

**ARTICLE II**

The principal street address and mailing address is 518 Driftwood Road, North Palm Beach, Florida 33408.

**ARTICLE III**

The purpose for which the corporation is organized is exclusively for charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, as now enacted or hereafter amended, including, for such purposes, the making of distributions to organizations that also qualify as Section 501(c)(3) exempt organizations. To this end, the corporation shall give support to the varsity and junior varsity baseball programs at Suncoast Community High School in Riviera Beach, Florida through various forms of fundraising. All funds, whether income or principal, and whether acquired by gift or contribution or otherwise, shall be devoted to those purposes. Should this corporation be dissolved, after payment of any debts, any remaining assets of the corporation shall be provided to the School District of Palm Beach County.

**ARTICLE IV**

The manner in which the directors are elected or appointed shall be by majority vote of all voting members present at the July meeting of the corporation.

**ARTICLE V**

The initial directors and/or officers of the corporation have not been selected at this time.
