ARTICLES OF INCORPORATION

OF

THE VIRGINIA ZEANI AND NICOLA ROSSI-LEMENI FOUNDATION, INC. <u>a Florida Not-for-Profit Corporation</u>

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not-For-Profit Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE ONE: NAME

The name of the Corporation is **THE VIRGINIA ZEANI AND NICOLA ROSSI-LEMENI FOUNDATION, INC.** ("Corporation").

ARTICLE TWO: PRINCIPAL OFFICE

The address of the principal office of the Corporation is 12765 Forest Hill Blvd., Suite 1302, Wellington, Florida 33414-4781.

ARTICLE THREE: PURPOSE

A. The Corporation is organized for the primary purpose of (1) the fostering of appreciation for the art opera, (2) opera vocal training and education; and (3) the preservation, conservation, and display of mementos, costumes, props, books, etc., associated with opera and the lives of Virginia Zeani and Nicola Rossi-Lemeni, collected individually and collectively over the careers (performing and teaching) of Virginia Zeani and Nicola Rossi-Lemeni. The Corporation is also organized for other not-for-profit purposes, substantially all of the activities of which are for the

aforementioned purposes. No part of the net earnings of the Corporation shall inure to the benefit of any officer or member of the Board of Directors.

B. In the event of a dissolution of the Corporation, the net assets thereof, after payment or other provision is made for any and all indebtedness and other liabilities of the Corporation, shall be delivered and paid over to an organization selected by the then Board of Directors which qualifies as an Exempt Organization under Section 501(c), or similar provision, of the Internal Revenue Code then in effect.

ARTICLE FOUR: DIRECTORS

At all times there shall be not less than three (3) Directors of the Corporation. The number of Directors in excess of three (3) and the method of their election are set forth in the Bylaws.

ARTICLE FIVE: MEMBERS

The Corporation shall have three (3) initial Members, Virginia Zeani (also known as Virginia Zeani Rossi-Lemeni); Virginia Zeani's son, Dr. Alessandro Rossi-Lemeni Makedon; and Virginia Zeani's trusted friend, Leslie M. Ritch. The initial Members of the Corporation shall serve in that capacity until their resignation, disability or death. Upon the resignation, disability or death of an initial Member, a successor may be appointed as provided in the Bylaws. Additional Members may be admitted from time to time as set forth in the Bylaws. The Members of the Corporation shall serve on the Board of Directors at all times. The Bylaws of the Corporation contain provisions relating to the qualifications for membership, the rights of members, and other such matters.

ARTICLE SIX: INITIAL REGISTERED AGENT AND ADDRESS
