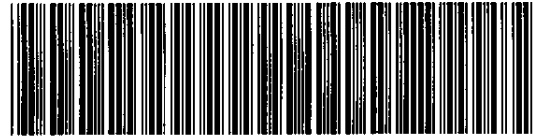

ARTICLE I
