ARTICLES OF INCORPORATION OF:**

**CoralGables@HOME, Corp.**

**(a Florida not-for-profit Corporation)**

Pursuant to provisions of Section 617.1007 (2) of the Florida Not For Profit Corporation Act, this not-for-profit corporation adopts the following Articles of Amendment to its Articles of Incorporation.

**FIRST:** Article III should be amended as follows:

**ARTICLE III**

**Purpose**

The Corporation is organized exclusively for religious, charitable, scientific, literary, and educational purposes, all within the meaning of Code Section 501(c)(3) of the Internal Revenue Code of 1986, as amended from time to time (the "Code") or the corresponding provision of any subsequent federal tax law.

**SECOND:** Article IV should be amended as follows:

**THIRD:** Article VIII should be amended as follows:

**ARTICLE VIII**  
**Board of Directors**

The affairs of the Corporation shall be managed by a Board of Directors consisting of no less than three directors. The election of directors shall be done in accordance with the Bylaws. The directors shall be protected from personal liability to the fullest extent permitted by law. 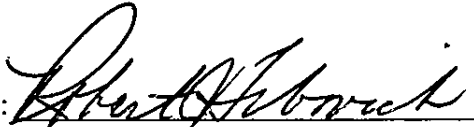
