

Attachment to
Articles of Incorporation of
Love & Light Assistance Corporation

This corporation is organized exclusively for one or more of the purposes as specified in Section 501(c)(3) of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code. This Corporation shall be a nonprofit corporation. The specific purpose for which this corporation is organized is: the purpose of our ministry is to assist the financially challenged and the homeless within the southwest Florida area. Our ministry is spiritually based and non denominational but our organization is not a church. We will be working with local area churches, food banks and accepting donations from both public and private donors at the individual and corporate levels. Our intent is to provide assistance in the following manner:

a) Providing food and water and other necessary items required for basic daily survival to homeless victims living on the street and or in wooded areas. b) Providing hot cooked meals and non alcoholic beverages to invited people when our organization conducts an event. Our goal is to hold at minimum one event per month with increased frequency as our corporation grows. c) Providing donated clothing, jackets and shoes. d) Directing said people to employment opportunities and county work programs when this is feasible. Our goal is to assist said people in redirecting their path in an attempt to help them change their lives on their own volition with our assistance. We will exhaust all avenues both public and private to assist these people utilizing our contacts within the local community. e) Our goal is to obtain property for bulk warehousing and distribution of food items and supplies to support our operations. f) We fully intend to place trucks and vans on the road to assist with transportation needs of both our corporate requirements as well as assisting the needy, dependent upon the specific need.

Upon the dissolution of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.

No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by Section 501(h) of the Internal Revenue Code), and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.

No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to, its members, directors, officers, or other private persons, except that this

corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these articles.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

All references to sections of the Internal Revenue Code shall include such sections as of the date hereof and the corresponding section of any future federal tax code.
