The purpose for which the corporation is organized is:

In accordance with the objective of AASC, the mission of the Florida Chapter shall be to advance the profession of Service Coordination and provide guidance to members in the creation and maintenance of service-enhanced housing to families, the elderly and persons with disabilities through education, training, networking, advocacy and other services.

**ARTICLE IV MANNER OF ELECTION**

As Stated in Bylaws:
