

The undersigned incorporator, for the purposes of forming a Florida not-for-profit corporation; hereby adopts the following Articles of Incorporation:

Article I

The name of the corporation is: Tibet Mongalom, Inc.

Article II

Article III: Purpose

To the extent permitted by Code Section 501©(3), The Corporation is organized exclusively for religious, educational and charitable purposes. All references to "Code" are to the Internal Revenue Code of 1986 as amended or to corresponding provisions of future tax legislation.

Article IV:

Directors shall be elected in accordance with the Corporate By Laws.

Article V: Membership:

All persons interested in the purposes of the Corporation are eligible for membership in the Corporation if they are capable of contributing to the achievement of those purposes and the effective operation of the corporation, and if they comply with the requirements established from time to time in the Bylaws. Members shall have no voting rights except as provided in the Bylaws.

Article VI: Limitations:

No part of the net earnings of the Corporation shall inure to the benefit of (or be distributed to) its directors, officers, members or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of any of its purposes. No substantial part of the activities of the corporation shall be the carrying on of propaganda or otherwise attempting to influence legislations, and the corporation shall not participate in, or intervene in (including the publishing or distributions of statements) any political campaign on behalf or in opposition to any candidate for public office. Notwithstanding any other provision of these Articles of Incorporation, the Corporation shall not carry on any activities except those permitted to carried on by a corporation exempt from federal income tax under Code section 501©(3) or by a corporation contributions to which are deductible under Code Section 170©(2) of the Internal Revenue Code.

Article VII: Board of Directors

The affairs of the Corporation shall be managed by a Board of Directors consisting of no less than three directors. The number of directors may be increased or decreased from time to time in accordance with the Bylaws of the Corporation, but may never be less than three. This election of directors shall be done in accordance with the Bylaws. The directors shall be protected from personal liability to fullest extent permitted by law.
