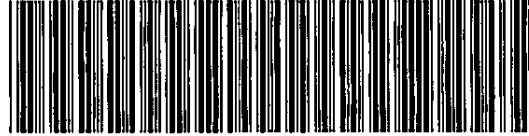

1. Article is hereby amended and restated to read in its entirety as follows:

PURPOSE STATEMENT

The purpose for which the Corporation is formed, and the business and objectives to be carried on and promoted by it are to operate a religious organization exempt from income taxation under Section 501(c)(3) of the Internal Revenue Code or corresponding section of any future federal tax code and as the same may be amended at any time and from time to time.

Except as otherwise limited herein, the Corporation shall have all power necessary or convenient to effect or transact any or all of the business or purposes for which the Corporation is organized and shall likewise have all the powers provided by the Act.

The Corporation is organized exclusively for charitable, religious and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the IRC.

2. A new Article is hereby added to the Articles of Incorporation. Article is hereby amended and restated to read in its entirety as follows:

DISSOLUTION

Upon dissolution of this Corporation, the assets of the Corporation shall be distributed for one (1) or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code and as the same may be amended at any time or from time to time and/or to the federal government, or to a state or local government, for a public purpose.
