ARTICLES OF INCORPORATION

FOR JOSHUA'S HOUSE FOR GOLDEN RETRIEVER RESCUE, INC

ARTICLE I

NAME OF CORPORATION

The name of the Corporation shall be Joshua's House for Golden Retriever Rescue, Inc., a non-profit corporation.

ARTICLE II

PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The place in this state where the principal office of the Corporation is to be located is 1397 S. Ladera Terrace, Inverness, Florida 34452. The mailing address for the Corporation is P.O. Box 513, Lecanto, Florida 34460.

ARTICLE III

PURPOSE

Said corporation is organized exclusively for charitable and educational purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future tax code. To this end, the corporation shall provide for the rescue, veterinary care, foster care, and adoption of unwanted, abandoned, neglected, mistreated or abused Golden Retrievers. Joshua's House for Golden Retriever Rescue, Inc. seeks to educate and inform the general public with respect to issues related to the care and adoption of Golden Retrievers. Through an all volunteer organization Joshua's House for Golden Retriever Rescue, Inc. seeks to do all things necessary for the operation of a golden retriever rescue and adoption service. All funds, whether income or principal, and whether acquired by gift or contribution or otherwise, shall be devoted to said purposes.

ARTICLE IV

ELECTION OF OFFICERS AND DIRECTORS

The officers of the Corporation shall be President, Vice President, Secretary, and Treasurer. The officers shall be elected annually by the Board of Directors at the May meeting.

ARTICLE VIII

LIMITATIONS

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Three hereof. No substantial part of the activities of the corporation shall be in the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any

future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE IX

DISSOLUTION OF CORPORATION

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
