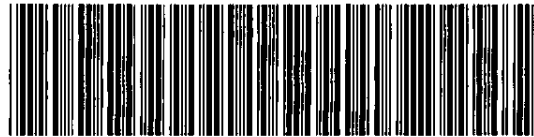

ARTICLES OF INCORPORATION
In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

The name of the corporation shall be:

Breedlove Outreach Ministries of Jesus Christ, Inc.

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

Breedlove Outreach Ministries of Jesus Christ, Inc., is a PUBLIC BENEFIT nonprofit corporation that is organized and operated exclusively for charitable and educational purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. Specifically, this nonprofit corporation is organized and operated to aid the poor and disadvantaged individuals and families toward a life of self-sufficiency and other programs to aid those in need and such purposes shall include the following:

- a) Religious
- b) To conduct a local Church by the direction of the Lord Jesus Christ and under the leadership of the Holy Spirit in Accordance with all of the Commandments and provisions as set forth in the Holy Bible, the irrevocable word of God, pursuant thereto, the following activities and guidelines shall be established:
 - (I) To disseminate the gospel of Jesus Christ and the Word of God, to the end that the people of God may be conformed to the image of God.
 - (II) To pray for and counsel couples for the healing of their marriages, so that the home life of each member is healthy and fruitful by biblical standards.
 - (III) To regularly assemble together the members of this church fellowship one with another and to worship God in spirit and truth; and to cooperate in assembling of the whole body of Christ.
 - (IV) To provide basic New Testament discipleship in its fellowship and activities and in the move of the Holy Spirit.

- (V) To baptize in water; to anoint the sick with oil; to marry; to dedicate infants; to celebrate the Lord's Supper; and to bury.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth above. No part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of any candidate for public office. Notwithstanding any other provisions, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from Federal Income Tax under section 501 (c)(3) of the Internal Revenue Code, or corresponding provisions of any future United States Internal Revenue Code.
