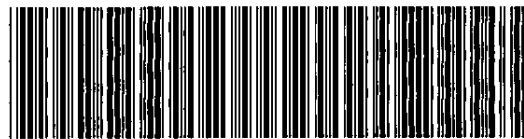

ARTICLE I

CORPORATE NAME

The name of this Corporation is Sweet Gum Holiness Church of Washington County, Inc.

ARTICLE II

ARTICLE III

CORPORATE NATURE

This is a non-profit corporation, pursuant to the Florida Corporations Not-For-Profit Law set forth in Section 617 of the Florida Statutes organized solely for religious purposes as provided for in Florida Statute 237.40.

ARTICLE IV

MANNER OF ELECTION

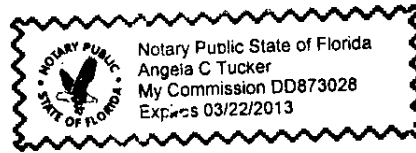
