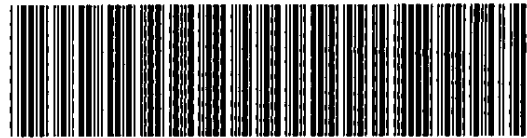

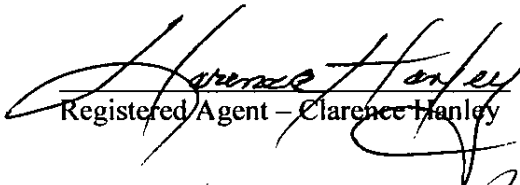
ARTICLE VIII- DISSOLUTION

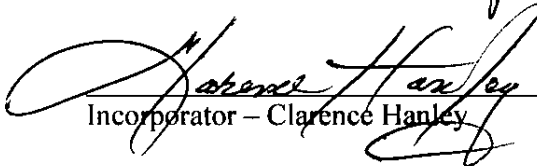
