The undersigned incorporator, a citizen of the United States, desiring to form a Corporation Not for Profit under the Corporation Not for Profit Law of Florida, Chapter 617, Florida statutes, hereby adopts the following Articles of Incorporation:

**ARTICLE I**

**NAME**

The name of the Corporation Not for Profit shall be: The Living Pieces Project, Inc.

**ARTICLE II**

**PRINCIPAL OFFICE**

**ARTICLE III**

**PURPOSE**

1. The purposes for which the Corporation is organized are exclusively educational, scientific, literary, and charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, or the corresponding provision of any successor United State Internal Revenue law.
2. The Corporation, in order to implement these purposes, shall conduct and/or support educational, literary, scientific and charitable activities relating to art, science, health, history, food, literature, local and/or world culture(s), and/or the relationship(s) between biological diversity and human society.
3. These purposes shall be broadly interpreted to allow the Corporation flexibility in engaging in all activities that promote the interests of the corporation, so long as the same do not adversely affect the Corporation's tax-exempt status for federal income tax purposes.
4. The Corporation may engage in fundraising activities to fund its operations and for other charitable purposes.
5. No part of the net earnings of this Corporation shall inure to the benefit of, or be distributable to, its members, directors, officers, or other private persons, except that this Corporation shall be authorized to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these articles.
6. No substantial part of the activities of the Corporation shall consist of the carrying on of propaganda, or otherwise attempting to influence legislation (except as otherwise provided by Section 501(h) of the Internal Revenue Code), and this Corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.

**ADDITIONAL PROVISIONS**

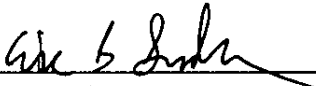
