### **E) Amending Article III**

With the earthquake of Haiti, and the need for helping the orphans kids that lost their parents, and sleeping in the streets in the most affected communities in the surrounding of the capital, our organization has refocus its goals, and decided to raise money in order to provide shelters, clothes, food, and education to these disaffected children.

### **F) Amending Article IV**

In this article the manner of electing the officers, and the directors will stay the same, except that, for the first two years, they will be by the president, then, at the end of their second term, the executive committee will appoint a search committee, and a nominating committee. The search committee will present new candidates for different positions to the nominating committee whose role will be to investigate their qualifications.

Another change is that the executive committee will incorporate in its rank officers and directors of committees in Haiti.
