#### Amendment I to the Constitution of Epic Ministries, Inc.

This amendment seeks to extend the term of Rich Carr, Elder (non-staff member) indefinitely until it is determined by the Board of Elders of Epic Ministries, Inc. to begin his four-year term. Once his four-year term is enacted by the Board of Elders, then the Elders will follow the requirements for *The Election of Elders* as outlined in *The Official Constitution of Epic Ministries, Inc.* 

This amendment has been proposed by the Board of Elders and seeks to be ratified by those who are currently on the Board of Elders, the Executive Staff Team, the Stewardship Team, the Personnel Team, and the Ministry Leaders Team which can participate to vote to amend the constitution. Approval by these groups requires a minimum participation of 75 percent of these various groups of the Epic Ministries, Inc. campuses through attendance, proxy, or written vote. This will constitute a quorum. All amendments require a two-thirds affirmative vote of those participating to pass.

There are currently 25 people of Epic Ministries Inc. that qualify to vote on this amendment. The quorum must contain at least 19 people to officially constitute a quorum. This amendment will pass with 13 people voting to pass the amendment.

Today, there are  $\frac{\sqrt[4]{2}}{\sqrt[4]{2}}$  people represented amongst the various approved groups who can amend the constitution.

Votes shall be cast by the quorum when asked to raise their hands to "yes" or "no." When the quorum raises their hands to "yes," their votes shall be counted and represent an affirmative vote to approve this amendment. When the quorum raises their hands to "no," their votes shall be counted and represent a vote that opposes this amendment.

All those in favor of the amendment raise your hand to vote "yes" at this time. The number of "yes" votes are 2.
