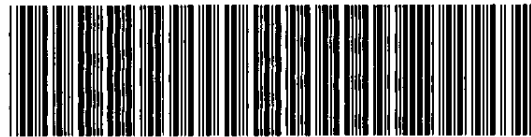

ARTICLE IX: ACTIVITIES



Private Christian Schools shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal Income tax under section 501 C (3) of the Internal Revenue Code, or the corresponding section of any further federal tax code, or (d) by a corporation, contributions to which are deductible under section 270(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE X: UPON DISSOLUTION

Upon the dissolution of Educators Inc. Private Christian Schools, assets shall be distributed for one or more exempt purposes with the meaning of section 501 C (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
