

The undersigned subscriber, a natural person competent to contract, hereby forms a non-profit corporation under the laws of the State of Florida and adopts the following Articles of Incorporation. This is a not for profit corporation organized solely not for pecuniary profit purposes, pursuant to the Florida Corporations Not For Profit law set forth in Chapter 617 of the Florida Statutes.

ARTICLE I - NAME

The name of the corporation shall be BOUNTIFUL BLESSINGS OUTREACH, INC.

ARTICLE II - PRINCIPAL PLACE OF BUSINESS

The initial principal place of business of this corporation in the State of Florida shall be, 944 S. Peninsula Drive, #109, Daytona Beach, FL 32118. The Board of Directors from time to time may move the principal office to any other address in Florida.
