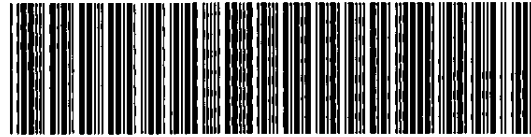

**Articles of Incorporation  
of  
Quick & Powerful, Inc.,  
A Non-Profit Corporation**

The undersigned subscriber of these Articles of Incorporation, being a natural person competent to contract, hereby subscribes to and forms a corporation not for profit under the laws of the State of Florida.

**ARTICLE I  
Name and Principal Office**

The name of the corporation is Quick & Powerful, Inc., a Non-Profit Corporation, and it shall have as its principal address: 872 Glenwood Road, DeLand, Florida 32720.

**ARTICLE II  
Duration**

The corporation is to exist perpetually, with commencement at the time of filing these Articles.

**ARTICLE III  
Purpose**

The purpose or purposes for which the corporation is organized are:

1. To publish and distribute materials to aid the learning and memorization of the Holy Bible; to promote the Christian faith; and to do all things incident and pertinent to such purposes, including the purchase, sale or lease of any real or personal property.

2. To transact any other lawful business for which corporations may be incorporated under the Florida General Corporation Act, or engage in any other trade or business which can, in the opinion of the Board of Directors of the corporation, be advantageously carried on in connection with or auxiliary to the foregoing purposes.

3. To do such other things that are incidental to the foregoing or necessary or desirable to accomplish the foregoing.

4. Further, the corporation is exclusively religious, charitable, scientific, literary, and educational within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law. Notwithstanding any other provision of these Articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from federal income tax under Section 501 (c)(3) of the Internal

Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

#### **ARTICLE IV**

##### **Registered Agent and Address of Registered Office**

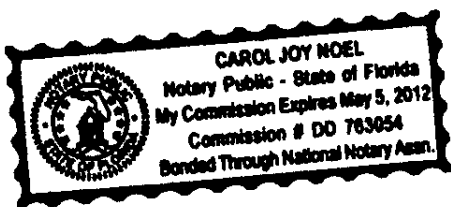
