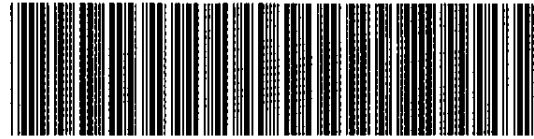

Articles of Incorporation

In compliance with Chapter 617, F.S., (Not for Profit)

The undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Florida, do hereby certify:

ARTICLE I NAME

The name of the Corporation shall be **Coconut Creek Multicultural Circle, Inc..**

ARTICLE II PRINCIPAL OFFICE

The place in this state where the principal office of the Corporation is to be located is the City of Coconut Creek at 3502 Bimini Lane N-1, 33066, Florida in Broward County.

ARTICLE III PURPOSE

Said corporation is organized exclusively for charitable, educational, and sharing the customs & multicultural experiences purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE IV MANNER OF ELECTION

Five directors/officers are elected each year and must be residents of the City of Coconut Creek, Florida.

The directors/officers are elected by a simple majority vote of the members of the Corporation that are present during the monthly meeting of second Tuesday of month of May during each year. The Corporation currently meets once a month on second Tuesday at 7:00 PM. The directors may decide to change time and day of a meeting.

ARTICLE V INITIAL DIRECTORS/OFFICERS

The elected directors/officers, residents of the City of Coconut Creek, Florida are as follows:

1. Ms. Mikkie Belvedere - President
2. Mr. Norman Cohen - V.P.
3. Ms. Dora Gould - Treasurer
4. Ms. Lata Gangal - Assistant. Treasurer
5. Ms. Audrey Thompson - Secretary

ARTICLE VI EARNINGS OF THE CORPORATION

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this Corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

ARTICLE VII DISSOLUTION OF THE CORPORATION

Upon the dissolution of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets, not so disposed of, shall be disposed of by a Court of Competent Jurisdiction of the Broward County in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

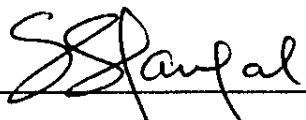
