The Corporation shall be operated exclusively for charitable, scientific, literary and/or educational purposes as described in section 501© (3) of the internal revenue code of 1954 or corresponding provision of any subsequent tax law ("code") including but not limited to the following particular purposes:

- 1) The deduction in the juvenile recidivism rate.
- 2) The promotion of family ties between incarcerated mothers and fathers and their children.
- 3) Early intervention for juvenile delinquency.
- 4) Prison program.
- 5) Community organizing.
- 6) In furtherance of the ongoing charitable, scientific, literature and/or educational purposes, the assets and earnings of this incorporation including but not limited to those assets or earnings derived from the interest on accounts program, exclusively for public purpose:
  - a) To provide video taped messages to juveniles from rehabilitated prisoners.
  - b) To promote prison tours by trouble teens.
  - c) To provide aid to poor families for sporting equipment.
  - d) For such other programs for the benefit of the public as are specifically approved by our Board of Directors to work at the grass roots level with local and state officials to curb overall teenage violence and crime rates, by working with local police, sheriff's and judges to identify and target those teens who need intervention, and to help save them by embracing them and their values by showing examples and providing hands on opportunities to promote optimal growth, ingenuity achievement and learning vital to their ambitions.
