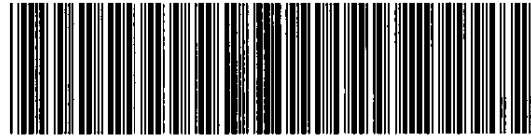

VIII.
