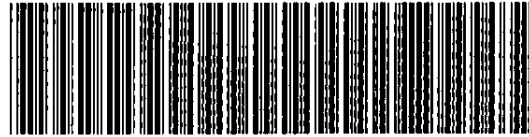

**ARTICLE II**

**PURPOSES**
