Pursuant to the provisions of section 617.1006, Florida Statutes, this **Florida Not For Profit Corporation** adopts the following amendments to its Articles of Incorporation on January 26, 2011, with an effective date of the same:

**Amending: Article III Specific Purpose**

This corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in compliance with sections 501 (c)(3) and 170 (c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

- Introduction
  - o This corporation was organized exclusively for religious, charitable, and educational services.
- Vision
  - o Due to the overwhelming needs in the Latin/Hispanic community, it is the *vision* of this corporation to enhance the lives, ensure success, and encourage prosperity.
- Mission
  - o In order to respond to the aforementioned needs of the Latin/Hispanic community and accomplish the vision, it is the *mission* of this corporation to establish the following ministries, although the following list is not limited to such:
