WE THE UNDERSIGNED SUBSCRIBERS, agree to form a non-profit corporation under the laws of the Sate of Florida, pursuant to these Articles of Incorporation as follows:

ARTICLE I
Name of Corporation

Duration of Corporation

This Corporation shall exist perpetually unless dissolved according to Florida Law.

Purpose

This non-profit corporation is organized for the purpose of housing men whose lives were disrupted by prison. And to assist men in achieving the common objective under which this corporation is organized. Nothing in the foregoing shall be deemed as prohibiting the corporation from extending its activities to any related or otherwise permissible lawful purpose which may become necessary or desirable for the furtherance of the corporate objectives expressed hereinabove.

ARTICLE IV

Membership

The membership of this corporation shall consist of all persons hereunder named as subscribers of these Articles of Incorporation, all persons on the Board of Directors of this Corporation and any and all persons who share in a common interest with the primary purposes and objectives of this corporation. The Board of Directors shall determine whether any applicant for membership meets the foregoing qualifications and if so, the applicant shall be admitted to membership in this corporation.

ARTICLE V

Address

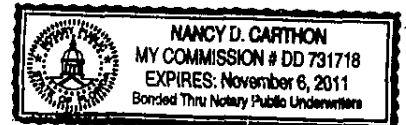
