The undersigned, acting as incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopt the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation shall be:

For the Children Too Inc.

ARTICLE II - PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The principal place of business and the mailing address of this incorporation shall be:

625 West Union Street, Suite #1 Jacksonville, Florida 32202

<u>ARTICLE III - PURPOSE(S)</u>

The specific purposes for which the corporation is organized are:

- (a) To develop as a legal resource office designed to assist in the process of placement of children in need who have been abandoned or neglected by their parents into the legal custody of relatives of such children and to undertake such activities which may facilitate a stable home environment.
- (b) No part of the net earnings of the corporation shall inure to the benefit of any member, director, trustee, officer of the corporation or any private individual (except that reasonable compensation may be paid for services rendered to or for the corporation affecting one or more of its purposes) and no member, director, trustee, officer of the corporation or any private individual shall be entitled to share in the distribution of any of the corporate assets upon dissolution of the corporation. No substantial part of the activities of the corporation shall be devoted to dissemination of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in or intervene in any political campaign on behalf of any candidate for public office, nor shall it publish or distribute campaign statements.
- (c) Notwithstanding any other provisions of these articles, the corporation shall not conduct or carry on any activities not permitted to be conducted or carried on by an organization exempt under Section 501(c)(3) of the Internal Revenue Code and its Regulations as they now exist or as

they may hereafter be amended, or by an organization, contributions to which are deductible under Section 170(c)(2) of such Code and Regulations as they now exist or as they may hereafter be amended.

ARTICLE IV - MANNER OF ELECTION OF DIRECTORS

The number of directors constituting the initial board of directors of the Corporation shall be four (4). The manner in which the directors are elected or appointed is as follows:

Directors shall be appointed by the president of the corporation whom is also a member of the board.

ARTICLE V - LIMITATION OF CORPORATE POWERS

The corporate powers of this corporation are as provided in Section 617.0302, Florida Statutes except that only such powers shall be exercised as are in furtherance of the tax-exempt purposes of the corporation and as may be exercised by an organization exempt under Section 501(c)930 of the Internal Revenue Code and its Regulations as they now exist or as they may hereafter be amended and by an organization, contributions to which are deductible under Section 170(c)(2) of such Code and Regulations as they now exist or as they may hereafter be amended.

ARTICLE VI - MEMBERSHIP

A. The initial voting members of the Corporation shall be:

Donald M. Robinson Deborah Davis Donna Robinson Pamela Y. Robinson

- B. Each member shall be entitled to one vote in all matters requiring membership approval.
- C. Membership shall be transferrable with the consent of a majority of the members of the corporation. If any member wishes to terminate its membership, it may do so by giving notice to the corporation. The corporation shall remain in existence and the remaining members shall continue to operate the business of a majority of the members of the corporation.

D. The corporation may have such additional classes of members as the Board of Directors shall from time to time direct.

ARTICLE VII - INCORPORATORS
