

ARTICLE I NAME

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

To provide encouragement, supportive outreach services, and service referrals to unsheltered homeless persons. The corporation is organized exclusively for charitable, religious, and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE IV MANNER OF ELECTION

The manner in which the directors are elected or appointed:

EFFECTIVE DATE 7-30-10

Initial Board of Directors appointed by the Incorporator to serve for a specified period determined by the Incorporator. Future Board of Directors to be selected by annual elections, after nominees are determined through the review board selection process. Future vacancies are to be filled by appointment of the Incorporator/Chair Person, as deemed necessary or until elections can be held. Upon the dissolution of the Corporation, the Board of Directors shall, after paying or adequately providing for all debts, obligations, liabilities of the Corporation, shall distribute the remaining assets of the Corporation exclusively for the nonprofit charitable purposes, shall distribute the remaining assets of the Corporation to such organizations which are tax exempt under 501(c) (3) of the Internal Revenue Code, as the Board of Directors in its sole discretion shall determine.
