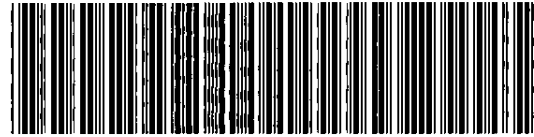

#### ARTICLE I - NAME OF ORGANIZATION

The name of the Corporation shall be ROOSEVELT A. LOVE FOUNDATION, INC.

#### ARTICLE II - PRINCIPLE OFFICE

The place in this state where the principal office of the Corporation is located is 3838 First Avenue South, St. Petersburg, FL 33711, County of Pinellas.

#### ARTICLE III - PURPOSE OF ORGANIZATION

This corporation is organized exclusively for charitable and educational purposes as specific within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amend, for such purposes, the making of distributions to organizations that also qualify as Section 501(c)(3) exempt organizations. To this end, the corporation shall provide comprehensive housing counseling to include, but not limited to pre- and post occupancy housing counseling, debt and financial management counseling, default and delinquency counseling, provide maintenance, financial management, and such other matters as may be appropriate to assist them in improving their housing conditions and in meeting the responsibilities of tenancy or homeownership; provide services to homeowners assisted under Section 235 and Section 237 of the National Housing Act; including, conventional and privately referred families and businesses facing financial default/delinquency on home and business loans. All funds, whether income or principal, and whether acquired by gift or contribution or otherwise, shall be devoted to said purposes.

#### ARTICLE IV - INITIAL DIRECTORS

The election, eligibility, rights and obligations of the board members will be determined by the organization's bylaws. The management and affairs of the corporation shall be at all times under the direction of a Board of Directors, whose operations in governing the corporation shall be defined by statute and by the corporation's by-laws. No Director shall have any right, title, or interest in or to any property of the corporation.

The corporation's first Board of Directors shall be comprised of the following three (3) persons:


Members of the initial board of directors shall serve until the first annual meeting, at which their successors will be duly elected and qualified, or removed as provided in the bylaws.


