## Articles Of Incorporation 10 JUL 27 PM 2: 20 Of SECRETARY OF STATE CHRIS JOHNSON 28 FOUNDATION, INC. A NONPROFIT CORPORATION

The undersigned, natural person of the age of eighteen years or older, acting as incorporator for the purpose of creating a nonprofit corporation under the laws of the State of Florida in compliance with Chapter 617, F.S., do hereby set forth:

Article I The name of the corporation is **Chris Johnson 28 Foundation, Inc.** 

Article II The principal place of business and mailing address of this corporation is:

Article III The purposes for which the corporation is organized are:

- a. <u>Chris Johnson 28 Foundation, Inc.</u> organized for exclusively religious, charitable, educational and scientific purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under said Section 501(c)(3) of the Internal Revenue Code of 1986.
