Amendment to the Articles of Incorporation of Brevard Community Partnership, Inc.

The following Article(s) of Incorporation are hereby amended:

Article Three: §3.01

- B) to promote, facilitate, assist and finance the creation of affordable housing for sale or rent and to assist local governments in carrying out effective community development and project planning and design activities to revitalize existing communities, expand economic development and employment opportunities, improve housing conditions and expand housing opportunities to persons of low and moderate income and otherwise providing direct benefit to persons of low and moderate income as outlined in the Florida Small Cities Community Block Grant Program Act (constituting Fla. Stat. §§290.0401 - 290.049 and other statutes and programs listed below. It shall serve as a catalyst for community action, a conduit for funds and an advocate for people who desire better and affordable housing but who are not organized for such purposes. The corporation shall also be authorized to engage in such other business activities as may be necessary or permissible for the forgoing purposes, including real estate development, construction, property management and the coordination of the delivery of social services incidental or related to the purposes prescribed by the Florida Small Cities Community Development Block Grant Program Act. In order to facilitate the ends and purposes described in paragraphs A and B of this Article III, the corporation may elect to obtain the following certifications:
 - a "community development corporation" under the Florida Small Cities Community Development Block Grant Program Act:
 - a "local development corporation" as defined in the Community Block Grant regulations contained in Title 24 C.F.R. §570.204 (C0 (3):
 - a conduit for Small Buisness Administration funds pursuant to section 301 (d) of the Small Buisness Investment Act of 1958, as amended;
 - a "community housing development organization" under the HOME Investment Partnership Program (Title 24 C.F.R. Part 92);
 - a "community-based organization" or a "neighborhood housing services corporation" under chapter 420 parts IV, V, VI and VII, Florida Statutes;
