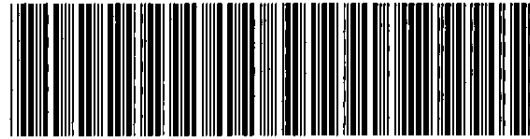

ARTICLES OF INCORPORATION
OF

In compliance with the requirements of the laws of the State of Florida, the undersigned hereby associate themselves together for the purpose of forming a corporation not for profit under Chapter 617, Florida Statutes, as amended, and do hereby certify:

ARTICLE I
NAME

The name of the Corporation is Songs for Christ, Inc., herein called "Songs for Christ."

ARTICLE II
REGISTERED AGENT

The name of the Registered Agent is Donald Robinson and the Registered Office is 2929 Edwards Road, Lady Lake, Florida 32159.

ARTICLE III
PURPOSE

Section 1. Purpose. The primary purpose of Songs for Christ is to promote and share the love of Jesus Christ through song and worship.

Section 2. Nonprofit Character of Songs for Christ. Songs for Christ does not contemplate pecuniary gain or profit, direct or indirect, to its Members. Songs for Christ shall make no distributions of income to its Members, Directors or officers, except those performing services may be compensated a fair wage for services rendered for Songs for Christ.

ARTICLE IV
POWERS

Songs for Christ shall have all the powers and duties reasonably necessary to fulfill its purposes, including, but not limited to:

(a) To exercise all the powers and privileges and to perform all of the duties and obligations of the Corporation as set forth in the Bylaws.

(b) To have and to exercise and any all powers, rights and privileges which a non-profit corporation organized under the laws of the State of Florida may now or hereafter have or exercise.

(c) To enter into, make, perform or enforce contracts of every kind and

description; and all other acts necessary, appropriate or advisable in carrying out any purpose of Songs for Christ with or in association with any corporation or other entity or agency, public or private.

ARTICLE V **MEMBERSHIP**

The member of Songs for Christ consists of Donald Robinson and any others he appoints as members. All members agree to be bound by the terms and provisions of these Articles of Incorporation and Songs for Christ's Bylaws.

The voting members of Songs for Christ shall consist only of David Robinson and those appointed by him.

ARTICLE VI **BOARD OF DIRECTORS**

The affairs of Songs for Christ shall be managed by no more than three (3) voting members of the Board of Directors.

Each voting Director shall serve for a term of three (3) years, although terms may be staggered as determined by the Board of Directors. Each Director's term shall begin following election by Song for Christ's Board of Directors in accord with the Bylaws. Each Director's term shall expire following the third year of service.

Directors named in these Articles shall serve until the first election of Directors, and any vacancies in their number occurring before the first election shall be filled by the remaining Directors. Directors shall be elected by Songs for Christ's Board of Directors in accord with the Bylaws of Songs for Christ. Directors may be removed by a two-thirds (2/3) majority vote of the members of the Board of Directors. The names and addresses of the members of the first Board of Directors who shall hold office until their successors are elected and have qualified, or until removed, are as follows:

ARTICLE VII **DISSOLUTION**

In the event of the dissolution of Songs for Christ, the assets of Songs for Christ shall be dedicated to an appropriate not for profit corporation or public agency to be used for purposes similar to those for which this corporation was created.

ARTICLE VIII

DURATION

The corporation shall exist perpetually.

ARTICLE IX AMENDMENTS

Amendments to the Articles of Incorporation shall be proposed and adopted in the following manner:

Notice of Amendment. Notice of the subject matter of a proposed amendment shall be included in the written notice of any meeting at which a proposed amendment is considered. The Articles of Incorporation may be amended by a majority vote of the voting members of the Board of Directors.

ARTICLE X OFFICERS

The Officers of Songs for Christ shall consist of a President, Vice-President, Secretary and Treasurer. The offices of Secretary and Treasurer may be held by one individual.

The names and addresses of the officers who shall serve until their successors are designated by the Board of Directors are as follows:

President: Donald Robinson
Treasurer: Donald Robinson
Secretary: Donald Robinson

ARTICLE XI BYLAWS

The original Bylaws of Songs for Christ shall be adopted by a majority vote of the Directors. Thereafter, the Bylaws of Songs for Christ may be amended, altered or rescinded at any regular or a special meeting of the Board of Directors.

ARTICLE XII INDEMNIFICATION OF OFFICERS AND DIRECTORS

Songs for Christ shall and does hereby indemnify and hold harmless every Director and every Officer, their heirs, executors and administrators, against all loss, cost and expenses reasonably incurred in connection with any action, suit or proceeding to which he may be made a part by reason of his being or having been a Director or

Officer of Songs for Christ, including reasonable counsel fees, except as to matter wherein he shall be finally adjudicated in such action, suit or proceeding to be liable or guilty of gross negligence or willful misconduct. The foregoing rights shall be in addition to, and not exclusive of, all other rights to which such Director or Officer may be entitled.

ARTICLE XIII
TRANSACTION IN WHICH DIRECTORS OR OFFICERS ARE INTERESTED

No contract or transaction between Songs for Christ and one or more of the Directors or Officers, or between Songs for Christ and any other corporation, partnership, association, or other organization, or a corporation in which one or more of its Officers or Directors are Officers or Directors of this corporation shall be invalid, void or voidable solely for this reason, or solely because the Officer or Director is present at, or participates in, meetings of the Board or committee thereof which authorized the contract or transaction, or solely because said Officers or Directors' votes are counted for such purposes. No Director or Officer of Songs for Christ shall incur liability by reason of the fact that said Director or officer may be interested in any such contract or transaction.

Interested Directors may be counted in determining the presence of a quorum at a meeting of the Board of Directors or of a committee that authorized the contract or transaction.

IN WITNESS WHEREOF, for the purpose of forming this Corporation under the laws of the state of Florida, I, the undersigned, constituting the incorporator of Songs for Christ, Inc., have executed there Articles of Incorporation, this 29th day of July, 2010.
