ARTICLES OF INCORPORATION

Of Life Training Institute China Inc. The undersigned, a majority of whom are citizens of the United States of America, desiring to form a non-profit Corporation under the Non-Profit Corporation law of Florida, Do hereby certify:

ARTICLE I

NAME

The name of the organization shall be: **LIFE TRAINING INSTITUTE CHINA INC.**

ARTICLE II

OFFICES

SECTION 1. Principal Office

The principle place of business and mailing address of this shall be: 5510 S.W. 52nd Avenue Gainesville, 32608 in Alachua County, Florida. The directors may change the principal office from one location to another. The secretary on these Articles opposite this section shall note any change of this location, or this section may be amended to state the new location.

ARTICLE III

PURPOSE

The purpose for which the corporation is organized: Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

- (1) In that Jesus the Messiah said "I came to give you life and life to the full", we obey the teachings of the Jewish and Christian Holy Bible to share that full life with as many people as possible by proclaiming the good news of salvation by faith in our Lord Jesus Christ by any suitable method or media, which includes but is not limited to the following:
 1. (a) Establishing an operating Schools for teaching the Holy Scriptures, the teachings of Jesus Christ and teaching English as a second language to foreign nationals using classrooms, computers, MP3 players, MP4 players, television, radio, tapes and recorded material

as well as other media devises, arranging crusades, classrooms, conventions, preaching, teaching, arranging various trips, out reach trips, charitable projects, and for other charitable purposes.

- (b) Assisting and furthering the task of providing Biblical Scripture and training to groups of the world through the Holy Scriptures and other printed material by providing speakers and other instructional and educational programs which may be deemed necessary or convenient in effecting the above purposes:
 - (c) Establishing of new programs of outreach and ministry and the strengthening of existing programs and organizations which have a similar purpose and dedication to presenting Christ as Savior including but not limited to caring for orphans and other children by providing care and schooling to meet their needs and better their lives.
 - (d) To ordain ministers and send them out according to the Holy Scriptures. To anoint workers in the Church to do the work of ministry as outlined in the 66 books of the Christian Bible.

- (2) To be obedient to our Lord Jesus Christ's command to "Go ye therefore, and teach all nations, baptizing them in the Name of the Father, and of the Son, and of the Holy Spirit";
 - (3) To serve as an instrument through which men may be taught and trained to be witnesses unto our Lord Jesus Christ in Jerusalem, and unto all Judea, and in Samaria, and unto the uttermost part of the earth;
 - (4) To do only that which glorifies the Father, the Son, and the Holy Spirit including but not limited to helping people in need of food, shelter, education, job training etc. that will help them become good, productive citizens in their home country.
 - (5) To engage in spiritual work and services based upon the authority of the Holy Bible.
 - (6) To equip Apostles, Prophets, Evangelists, Pastors, Teachers, Elders, Deacons and Servants for the perfecting of the saints, for the work of the ministry, for the edifying believers and followers of Jesus Christ in the Church around the world also known as the body of Christ .
 - (7) To solicit, collect, receive, acquire, hold and invest money and property, both real and personal, including money and property received by gift, contribution, bequest, or devise; to sell and convert property, both real and personal, into cash, and to use the funds of this corporation and the proceeds, income, rents, issues, and profits derived from any property of this corporation for any of the purposes for which this corporation is formed;
 - (8) To purchase, acquire, own, hold, sell, assign, transfer, dispose of mortgage, pledge, hypothecate, or encumber, and to deal in shares, bonds, notes, debentures, or other securities or evidences on indebtedness or any person, firm, corporation, or association and, while the owner or holder of them, to exercise all rights, powers, and privileges of ownership;
 - (9) To purchase or acquire, own, hold, use, lease (either as lessor or lessee), sell, exchange, assign, convey, dispose of, mortgage, hypothecate, or encumber real and personal property;

- (10) To enter into, make, perform, and carry out contracts of every kind for any lawful purpose without limit on amount, with any person, firm, association or corporation, municipality, county, parish, state, territory, country, government or other municipal or governmental subdivision.
- (11) To borrow money, incur indebtedness, and to secure repayment by mortgage, pledge, deed of trust, or other hypothecation of property, both real and personal, and
- (12) To do all things necessary, expedient, or appropriate to the accomplishment of any of the objects and purposes for which this corporation is formed.

ARTICLE IV

INITIAL DIRECTORS/OFFICERS

SECTION 1. NAMES AND ADDRESSES OF TRUSTEES, DIRECTORS AND OFFICERS

The officers of the corporation shall be a chairman of the board/president, a secretary, and a treasurer/chief financial officer. The corporation may also have, at the discretion of the board of directors, one or more vice presidents, one or more assistant secretaries, one or more assistant treasurers, and such other officers as may be appointed in accordance with the provisions of Section 3 of this Article VIII. The same person in accordance with Federal and State laws may hold any number of offices.

SECTION 2. Number, Term, and Election of Directors

The Board of Directors shall consist of no less than three (3), and no more than nine (9) Directors.

The Board of Directors shall first be appointed by the organizer of this corporation, and thereafter shall be elected by the preceding Board of Directors at their annual meeting. Each Director shall serve a term of one (1) year. A Director may succeed himself. Each Director, including a Director elected to fill a vacancy, shall hold office until the expiration of the term for which elected and until a successor has been elected.

ARTICLE V

COMPENSATION AND NONPARTISAN ACTIVITIES

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE VI

DEDICATION OF ASSETS,

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes defined in Article three or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
