ARTICLES OF INCORPORATION EVERYONE HAS A STORY, INC.

The undersigned, as incorporator and on behalf of a not-for-profit, non-stock corporation under the laws of the State of Florida, hereby adopts the following Articles of Incorporation.

NAME ARTICLE I

Section 1.1. The name of the corporation shall be Everyone Has A Story, Inc., (the "Corporation).

ARTICLE II

Section 2.1. The principal place of business and mailing address shall be: SAN AO Loblelly Circle Midway, 7L 32343

CLE III PURPOSES(S)

ARTICLE III

- The specific purposes for which the corporation is organized are Section 3.1. 3exclusively for religious, educational, and charitable purposes, either directly or by contributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code and Regulations issued pursuant thereto, as they now exist or as they may hereafter be amended.
- The Corporation shall have the power, either directly or indirectly, either alone or in conjunction or cooperation in with others, to do any and all lawful acts and things to engage in any and all lawful activities which may be necessary, useful, suitable, desirable or proper for the furtherance, accomplishment, fostering or attainment of any and or all of the purposes for which a Corporation is organized and to aid or assist other organizations whose activities are such as to further accomplish, foster or attain any of such purposes. Notwithstanding anything herein to the contrary, the Corporation shall exercise only such powers as are in furtherance of the exempt purposes of organizations set forth in Section 501(c)(3) of the Internal Revenue Code of 1986 and the regulations thereunder as the same now exist or as they may be hereinafter amended from time to time.
- No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate or intervene in (including the publication of distribution of statements) any political campaign on behalf of any candidate for public office.
- Section 3.4. The Corporation shall not conduct or carry on any activities not permitted to be conducted or carried on by an organization exempt from taxation under Section 502(c)(3) of the Internal Revenue Code and Regulations issued pursuant thereto as they now exist as they

may hereafter be amended, or by an organization contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code and said Regulations as they now exist or as they may hereafter be amended.

ARTICLE IV MANNER OF ELECTION OF DIRECTORS

- Section 4.1. The affairs of the Corporation shall be governed by a Board of Directors (hereinafter referred to as the "Board"), subject to the restriction that, except as specifically set forth to the contrary in the Bylaws, the exercise of any powers or actions of the Board shall require the approval thereof by a majority vote of the Board present at a meeting at which a quorum of no less than two (2) Directors are present. The affirmative vote of any two (2) Directors shall be necessary for all corporate action requiring a vote of the Boatd, including, but not limited to the following:
- 4.1.1. Approval of charitable gifts, transfers, distributions and grants by the Corporation to other entitites.
 - 4.1.2. Adoption of an amendment to the Articles of Incorporation or the Bylaws.
 - 4.1.3. Organization of a subsidiary or affiliate by the Corporation.

Section 4.2. Except for the initial Board of Directors, whose names are set forth in these Articles of Incorporation, the Board of Directors shall be elected or appointed as provided in the Bylaws.
