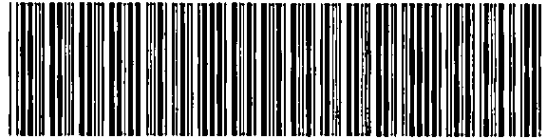

Articles of incorporation amended from Casa de Fe, Asambleas de Dios, Inc.

The undersigned by means of the following articles and according to the law of the state of Florida have decided to amend the articles of incorporation of our non-profit organization.

The Board of directors by resolution of such date has decided to amend and adopt the following articles so that in the future it is read as follows:

Article I

That the name be changed from CASA DE FE ASAMBLEAS DE DIOS to
M. I. CASA DE FE, Inc.

Article II

Change our address from 11373 Sand Hill, Ave Spring Hill, FL 34608 to
1289 Kass Circle Spring Hill, FL 34606 as our main address.

And keep the address 11373 Sand Hill, Ave Spring Hill, FL 34608 as our address to
receive correspondence mail.



Article III

This will read: The specific purpose by which this corporation exists is to be
organized as a non-profit, religious and charitable organization according to section
501 (c) (3) Code of 1986.

This corporation is organized for:

- A. Praising Jesus Christ and preaching the Gospel of God's kingdom to every creature;
- B. Establish places of worship and teaching of the gospel,
- C. To instruct our community and the nation, in ethical conduct, to teach integrity, holiness, according to the Word of God;
- D. Support missionaries, evangelists; Carry out humanitarian activities;
- E. ordaining and licensing ministers of the Holy Gospel of Jesus Christ;
- F. Organize and support educational, charitable activities that help and orient the poor in our communities always in the order of the Holy Gospel of Jesus Christ;

- G. It is organized as a non-profit institution to operate exclusively for religious purposes within the meaning of section 501 (c) (3) of the year 1986 and its amendments;
- H. baptizes in water, dedicate children to the Lord, and share the bread and wine that symbolize the body and blood of Christ Jesus;
- I. Establish radio and television for the preaching of the gospel.
- J. Publish books, and other materials for gospel preaching.
- K. Solve problems, and marital conflicts in households, so that we are healthy families.

Article IV

Article VIII

The purpose of this corporation is that it exists forever or perpetually; but in the case or event of the dissolved assets thereof may not be distributed between its directors, and private persons; But rather they could be used for the payment of the commitments made by the corporation and the surplus assets will be distributed between one or more charitable or religious institutions under section 501 (c) (3) at the discretion of the President of the Corporation and failing by the Council of Directors or seniors, or by the Court of this city or jurisdiction in the event that the Council is unable to do so.

Article IX

This corporation may have members. The eligibility and the right of the Members shall be determined by the statutes.

Article X

The Statutes of this corporation have been adopted by the Board of directors or seniors, and this same Council can amend it, alter it, according to how they establish the statutes.



Article XI

Secular and corporate affairs will be administered by the board of directors or seniors who can serve without any monetary compensation.

Likewise, this Council of directors or seniors could be increased or decreased according to the statutes.

Directors may be removed in accordance with the provisions by the laws.

Article XII

Gifts

Directors, officers and seniors may accept gifts on behalf of the corporation, but they cannot dispose of them at their discretion, but will deliver them under inventory to the Corporation and the corporation reserves the right to use it for its purpose and at its discretion.

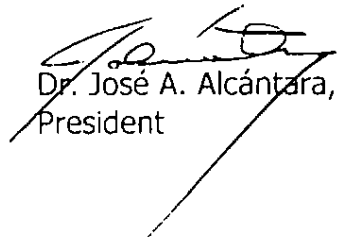
Article XIII
