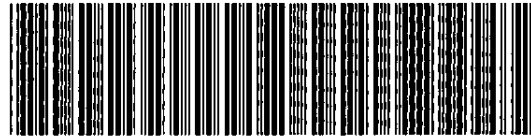

**ARTICLES OF INCORPORATION**  
**OF**  
**Open Source Automotive Electronics Initiative, Inc.**  
**A Florida "Not for Profit" Corporation**

SECRETARY OF STATE  
TALLAHASSEE, FLORIDA

The undersigned, acting as incorporator of a Corporation under Chapter 617 of Florida Statutes, adopts the following Articles of Incorporation:

- 1) **NAME OF CORPORATION:** The name of the Corporation is Open Source Automotive Electronics Initiative, Inc.
- 2) **PRINCIPAL OFFICE:** The principal office of the Corporation is located at 117 Mountain Drive, Destin, Florida 32541.
- 3) **MAILING ADDRESS:** The mailing address of the Corporation is 13740 Highway 20, Niceville, Florida, 32578.
- 4) **REGISTERED AGENT:** The name of the registered agent of the Corporation is Tommye L. Honaker, Jr. The address of this registered agent is 13740 Highway 20, Niceville, Florida, 32578.
- 5) **DURATION/MEMBERSHIP:** The period of duration is perpetual. The Corporation shall have no "members."
- 6) **BOARD OF DIRECTORS:** The method of selection of the Board of Directors and number of directors shall be stated in the bylaws. The names and addresses of the persons who are to serve as the initial directors, until the election of their successors, are as follows:

- 7) **INCORPORATOR:** The name and address of the incorporator is: Tommye L. Honaker, Jr., 13740 Highway 20, Niceville, Florida, 32578.
- 8) **CORPORATE PURPOSES:** The purposes for which this Corporation is formed are exclusively charitable, educational and scientific and consist of the following:
  - a) This Corporation is formed for the purpose of creating the major portions and components of an automotive electrical system via community effort. This Corporation shall accomplish this

goal by providing a website with provisions to support an online community, such as, but not limited to, a message board or similar discussion system, and online tools for managing and coordinating project development. This Corporation shall, wherever possible, make use of donations, gifts, contributions, and fundraising efforts to assist in, and where possible subsidize, development efforts on the part of the community.

- b. This Corporation is formed exclusively for charitable and educational purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
- c) To aid, support, and assist by gifts, contributions, or otherwise, other corporations, community chests, funds and foundations organized and operated exclusively for charitable or educational purposes, no part of the net earnings of which inures to the benefit of any private shareholder or individual, and no substantial part of the activities of which is carrying on propaganda, or otherwise attempting to influence legislation.
- d) To do any and all lawful activities which may be necessary, useful, or desirable for the furtherance, accomplishment, fostering, or attaining of the foregoing purposes, either directly or indirectly, and either alone or in conjunction or cooperation with others, whether such others be persons or organizations of any kind or nature, such as corporations, firms, association, trusts, institution, foundations, or governmental bureaus, departments or agencies.
- e) All of the foregoing purposes shall be exercised exclusively charitable and educational purposes in such a manner that the Corporation will qualify as an exempt organization under section 501 (c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

## **9) 501(c)(3) LIMITATIONS**

- a) **CORPORATE PURPOSES:** Notwithstanding any other provision of these articles, this Corporation shall not carry on any other activities not permitted to be carried on by an Corporation exempt from Federal and state income tax under section 501 (c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
- b) **EXCLUSIVITY:** The Corporation is organized exclusively for charitable and educational purposes.
- c) **NO PRIVATE INUREMENT:** The Corporation is not organized nor shall it be operated for the primary purpose of generating pecuniary gain or profit. The Corporation shall not distribute any gains, profits or dividends to the Directors, Officers, or Members thereof, or to any individual, except as reasonable compensation for services actually performed in carrying out the Corporation's charitable and educational purposes. The property, assets, profits and net income of the Corporation are irrevocably dedicated to charitable and educational purposes no part of which shall inure to the benefit of any individual.

d) **LOBBYING AND POLITICAL CAMPAIGNS:** No substantial part of the activities of the Corporation shall consist of the carrying on of propaganda or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in, any political campaign on behalf of any candidate for public office.

e) **DISSOLUTION:** Upon winding up and dissolution of the Corporation, the assets of the Corporation remaining after payment of all debts and liabilities shall be distributed to an organization recognized as exempt under section 501(c)(3) of the Internal Revenue Code of 1986 to be used exclusively for charitable and educational purposes. If the Corporation holds any assets in trust, such assets shall be disposed of in such a manner as may be directed by decree of the Circuit Court of the district in which the Corporation's principal office is located, upon petition thereof by the Attorney General or by any person concerned in the liquidation.

f) **"PRIVATE FOUNDATION" PROVISIONS:** In the event this Corporation is considered to be a "Private Foundation" by the U.S. Internal Revenue Service under provisions of the United States Code the following provisions apply:

i) The Corporation will distribute its income for each tax year at a time and in a manner as not to become subject to the tax on undistributed income imposed by section 4942 of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ii) The Corporation will not engage in any act of self-dealing as defined in section 4941(d) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

iii) The Corporation will not retain any excess business holdings as defined in section 4943(c) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

iv) The Corporation will not make any investments in a manner as to subject it to tax under section 4944 of the Internal Revenue Code, or the corresponding section of any future federal tax code.

v) The Corporation will not make any taxable expenditures as defined in section 4945(d) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

10) **INDEMNIFICATION** - Any person (and the heirs, executors and administrators of such person) made or threatened to be made a party to any action, suit or proceeding by reason of the fact that he is or was a Director or Officer of the Corporation shall be indemnified by the Corporation against any and all liability and the reasonable expenses, including attorney's fees and disbursements, incurred by him (or by his heirs, executors or administrators) in connection with the defense or settlement of such action, suit or proceeding, or in connection with any appearance therein, except in relation to matters as to which it shall be adjudged in such action, suit or proceeding that such Director or Officer is liable for negligence or misconduct in the performance of his duties. Such right of indemnification shall not be deemed exclusive of any other rights to

which such Director or Officer (or such heirs, executors of administrators) may be entitled apart from this Article.
