The undersigned person, as incorporator of a corporation not for profit under the Florida Not For Profit Corporation Act, adopts the following Articles of Incorporation for the Corporation:

Article I Name and Principal Address

The name of the Corporation is Downtown Clearwater Merchant's Association, Inc. The initial principal address of the Corporation is c/o Elise K. Winters P.A., 1006 Drew Street, Clearwater, FL 33755.

Article II Purposes

The purposes for which this Corporation is organized are exclusively those of a business league within the meaning of Section 501(c)(6) of the Internal Revenue Code of 1954, as amended. The general nature of the activities of this Corporation is the promotion and improvement of the common interests of the commercial abd industrial interests within the boundary of the Clearwater Downtown Development Board special taxing district in Clearwater, Florida.
