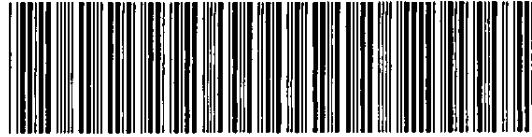

**ARTICLES OF INCORPORATION FOR FLORIDA NONPROFIT CORPORATION
OF
FORT LAUDERDALE STUDENT AMBASSADORS, INC.**

The undersigned natural persons of lawful age, for the purpose of forming a Nonprofit Corporation under F.S. 617.01 et seq., adopt the following articles of incorporation:

ARTICLE I: NAME AND PRINCIPAL OFFICE

The name of the Corporation is Fort Lauderdale Student Ambassadors, Inc., with its principal office located at 2656 Northeast 34th Street, Fort Lauderdale, Florida 33306. The Corporation's mailing address is Post Office Box 11362, Fort Lauderdale, Florida 33339-1362.

ARTICLE II: REGISTERED OFFICE AND AGENT

The name of the registered agent of the Corporation is McGee & Huskey, P.A. The street address of the registered office, which is also the address of the registered agent, is 2850 North Andrews Avenue, Fort Lauderdale, Florida 33311.

ARTICLE III: DURATION

The period of duration of this nonprofit corporation is perpetual.

ARTICLE IV: TYPE OF CORPORATION

The Corporation is a public benefit corporation, which is organized for community and public services and/or charitable purposes.

ARTICLE V: AUTHORIZATION

The Corporation is organized under F. S. 617.01 et seq and 26 U.S.C. 501(c)(3).

ARTICLE VI: PURPOSES

The purpose for which the Corporation is organized is to promote the involvement of high school students in community and public service projects within the City of Fort Lauderdale and for charitable purposes, and for all other legal purposes.

ARTICLE VII: NONSTOCK CORPORATION

The Corporation is nonstock and no dividends or pecuniary profits will be declared or paid to the members of the Corporation.

ARTICLE VIII: DIRECTORS

The number of directors constituting the initial board of directors of the Corporation is three (3), and the names and addresses of the persons who are to serve as initial directors are as follows:

ARTICLE IX: ELECTION OF DIRECTORS

The manner in which the Directors are to be elected by the members is as follows: At the annual meeting of each FTLSA Chapter's Members, Directors for each Chapter shall be elected by a plurality of the votes cast by the shares represented at the meeting and entitled to vote for the election of Directors. If the election of Directors is not held on a day designated in these Bylaws for any annual meeting of Members, or at any adjournment thereof, the Board of Directors may cause the election to be held at a special meeting of Members specifically called for that purpose.

ARTICLE X: CORPORATE OFFICERS AND THEIR FUNCTIONS

The general officers of the Corporation shall be President-Chief Executive Officer, Secretary, and Treasurer.

The principal duties of the President-Chief Executive Officer, shall be to preside at all meetings of the members and the board of directors and to have general supervision of the affairs of the Corporation.

The principal duties of the Secretary shall be to countersign all deeds, leases, and conveyances executed by the Corporation, affix the seal of the Corporation to all papers required or directed to be sealed, and to keep a record of the proceedings of the board of directors, and to safely and systematically keep all books, papers, records, and documents belonging to the Corporation, or in any way pertaining to the business of the Corporation, except the books and records incidental to the duties of the treasurer.

The principal duties of the Treasurer shall be to keep an account of all monies, credits, and property of the Corporation which come into his or her hands, and to keep an accurate account of all monies received and disbursed and of proper vouchers for monies disbursed, and to render all accounts, statements, and inventories of monies received and disbursed and of money and property on hand, and generally of all matters pertaining to the office of treasure, as required by the board of directors.

The board of directors may provide for the appointment of additional officers as they may deem for the best interest of the Corporation.

Whenever the board of directors may order, any two offices, the duties of which do not conflict, may be held by one person.

The officers shall perform additional or different duties as from time to time are imposed or required by the board of directors, or as may be prescribed from time to time by the bylaws.

ARTICLE XI: ELECTION OF OFFICERS

The officers shall be elected by the directors, who shall first be elected by the members of the Corporation.

ARTICLE XII: MEMBERSHIP

Membership in the Corporation shall be available to any natural person in a high school or in grades nine through twelve or at or above the legal age of 14 in Fort Lauderdale who is interested in furtherance of the purposes of the Corporation.

ARTICLE XIII: CLASSES OF MEMBERSHIP

The Corporation shall have one class of members, and no more than one membership may be held by any one person. The rights and privileges of all members shall be equal. Each member shall be entitled to one vote.

ARTICLE XIV: MEMBERSHIP DUES AND ASSESSMENTS

Membership dues to be paid is ten dollars for shirts along with any costs seen necessary and proper by a majority of members in a Fort Lauderdale Student Ambassadors Chapter and approved by Alexander Coffey Alghussain. Each chapter will work to keep operating costs to a minimum. The President of each chapter along with its Directors will be entrusted with the responsibility of collecting dues and assessments from the members of their respective chapters and

ARTICLE XV: DISSOLUTION

The Corporation may be dissolved without judicial supervision by adopting a resolution to dissolve, which must be approved by the Board of Directors and a by a majority vote of a quorum of its Members.

Upon dissolution, the remaining assets of the Corporation, if any, will be used to satisfy the debts of the Corporation, if any. Once the debts of the Corporation are satisfied, any remaining assets of the Corporation will be used to refund Membership Dues and Fees on a Pro Rata basis. If any funds still remain, the funds will be refunded to the donors of the Corporation on a pro rata basis.

ARTICLE XVI: AMENDMENTS

Amendments to these articles of incorporation may be proposed by a resolution adopted by the board of directors and presented to a quorum of members for their vote. Amendments may be adopted by a vote of at least 66 percent of a quorum of members of the Corporation.

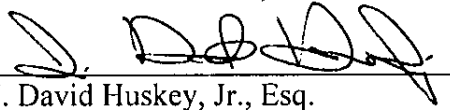

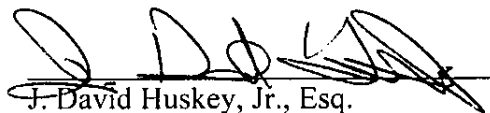
