The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I.

The name of the corporation shall be:

LakeBridge Church of the Nazarene, Inc.

EFFECTIVE DATE 8-8-10

ARTICLE II.

The duration of the corporation is perpetual unless dissolved according to the law. While the church was officially organized on May 23, 2010, the effective date upon which this corporation shall come into existence shall be August 8, 2010.

ARTICLE III.

The principal place of business and mailing address of this professional organization shall be:

ARTICLE IV.

The purpose for which the Corporation is as follows:

To establish and maintain a local congregation for the purpose of Christian ministry within the doctrine of the Church of the Nazarene as determined in their MANUAL.

ARTICLE V.

The terms of admission to membership in the Corporation shall consist of membership in good standing as determined by the Corporation. Membership shall be conditioned upon the acknowledgement and acceptance of the beliefs and tenants as published in the MANUAL of the Church of the Nazarene.

ARTICLE VI.

Should it be determined that this Corporation is to be dissolved, either voluntarily or involuntarily, the net assets of the Corporation shall be surrendered to the North Florida District, Church of the Nazarene, Inc. or its successor.

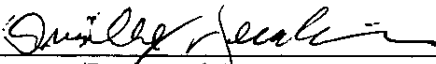
