Software purchased by corporation for the use and upkeep of the corporation, any access to free or paid websites that may

contain corporation information: including but not limited to IRS tax filing, payroll, etc, any information used about the

corporation informationally to the public set forth for the purpose and use of the corporation's purpose. This also includes an

and all paid as well as voluntary services that are used to set up intellectual property such as but not limited to websites, meaning that the work that is produced from said work is property of the corporation and at no time should be property of any individual person. To further this stand a copy of all user names and passwords that are created for the corporation of any such digital or written information will be furnished to the president of the corporation. In addition, any changed/alterd passwords, usernames, pin numbers must be first approved and provided to the president. Access to all intellectual and digital property of the the corporation is only permitted to those that are granted permission. Said permissions are granted on a need basis and not granted indefinitely. The permission does not carry outside of corporation use, permission will be revoked as soon as the person is no longer a member of the corporation or employee. Upon leaving the corporation the said person is to hand over any property that belongs to the corporation, including but not limited to: hardware, software, programs, files, etc. The said person is also forbidden from access to any of the said property belonging to the corporation. Usernames, Passwords, and or Pins of the corporation will be changed for safety of the corporation. All Passwords, Usernames, and Pins that are changed will be changed by the President or furnished to him for his records to abide with this amendment. The President will then decide who will have passwords, usernames, and pins so that the necessary running of the corporation may be continued. As to not confuse what applies, anything that is used for corporation's purposes or paid for by the corporation is the corporation's property.

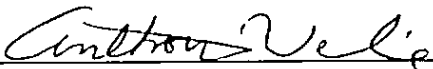
