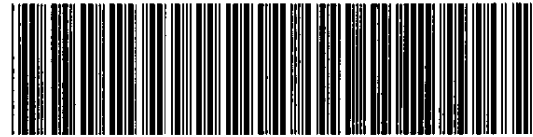

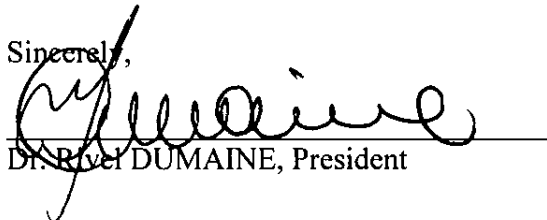

ARTICLES OF INCORPORATION

OF

VISIONIST CENTER OUTREACH GLOBAL MINISTRIES, INC.

(A Florida Non Profit Corporation Ministries)

I, Rivel Dumaine the undersigned, acting as incorporator and or subscriber of a Corporation pursuant to Chapter 617, Florida Statutes, adopt the following Articles of Incorporation of such Corporation as A Non Profit Corporation hereby and certify this Non Profit Incorporation shall constitute of Social Net- Work, Civics, and Religious Organizations and Association of Churches being of natural competent persons to promote, operate, and govern according to the laws of the Creator to fulfill the Visionary purposes of humanities and societies to execute the understanding of human kind to live up with dignity, respect, and prosperity for social, economic, spiritual growth, justice, and development. Thereunto, this corporation shall pursue all applicable provisions of the Statutes of the State of Florida relative to corporations Not for Profit, including the Unites States of America as shall dully authorized by Federal laws, and not limited to the International and Global laws guarantee the operation of a Non Profit Corporation. The Corporation shall secure its purposes under the Section 501(c) (3) of the Internal Revenue Code or the corresponding provisions of any future United States Internal Revenue Law and I hereby covenant, aspiration, incarnation, and inspiration agree to adopt these Articles of Incorporation as follows:

ARTICLE I- CORPORATE NAME

ARTICLE III -CORPORATE MISSION STATEMENT

ARTICLE X - PURPOSES

The specific and primary purposes for which this corporation is formed are:

- B. The specific purpose of this corporation is to provide social services, cultural performance, community development programs, skills and job training, to help the sick and the needy, community services, youth group meetings, bible study group meetings, prayer meetings, leadership training, Summer Camp programs and activities for kids, Youths, adults, to sing, teach, preach, proclaim, publish, make acknowledged, and disseminate by oral, written or other means the message of the Creator within its Context freedom from poverty, illiteracy, social, economic, and spiritual bounding, to encourage singing ministry, entertaining ministry, including the production of recording, books and other materials; and the conducting of seminars, study groups,

workshop and meeting in forum for the formation of young men, women, adult both men and women to better equip to worship God and serve mankind; ministerial credentials, religious purposes regardless of age, sex, race, religion, national ethnic background, sexual orientation, degree of disability status.

This organization is also being filed as A Non Profit organization for the purpose of applying for government funding including not limited private individuals and Institutions those are willing to support and fund this Non Profit Corporation as shall legally and lawfully authorized to act to such freely done by good faith and understanding. However, all funding shall carry on the basis that this corporation is A Non Profit Tax -Exempt Status and shall manage according to the signing contract that the funding sources required the distribution of such funds.

C. To share this institution beliefs, manifestations, and doctrines, through all legal means which are permitted by law of State and Federal Statutes of the United States, including? not limited to International, and global laws governing Non Profit Organization. To further its Mission by supporting and cooperating with various ministries established by men and women of God to empower people to fulfill their divine destiny to live a prosperous life with all the blessings necessary: Such as feeding, watering, sheltering, clothing, education, literacy, wealth, peace, justice, social, economic, and spiritual growth. To carry on and promote its mission-purposes through the use of radio, television, the internet, and the diversity of technology to further made known, heard, and opined about the reality of this mission-purposed.

D. To operate exclusively in any other manner for such religious, social services, cultural activities, community development programs charitable and educational purposes as will qualify its status as an exempt Organization under Section 501(c) (3) of the Internal Revenue Code of 1954, as amended, or under any corresponding provisions of any subsequent Federal tax laws, covering the distributions to organizations qualified as tax exempt Organizations under the Internal Revenue Code, as amended, including private Foundations and private operating foundations.

E. To encourage, promote, and establish union of Churches, Associations, Conventions, free from all sectarian and denominations Social and economic injustice.

F. To acquire Lands by purchase, lease exchange, gift or otherwise for erection of halls and other public building for the used and purpose of the Corporation.

G. To participate in such other businesses, whether related thereunto or not, as may approved by the Board of Directors, and or Trustees and which businesses are permitted by law within the meaning of Section 501 (c) (3) of the Internal Revenue Code.

H. Provide literacy programs based on the needs of different communities and organization meaning to public or private Non Profit Organizations of demonstrated effectiveness that fulfilling the vision of developing communities with different ethnics. Organizations may adopt the Articles of this Corporation by mean of affiliation. The Charter of this Corporation once given to others shall be for the providing of: Social, economic, charitable, educational, cultural, and or religious and or any related Non Profit Services as authorized by the State or States in question and under the Federal Laws and rules pertaining to the United States Federal Laws securing the forming of a Non Profit Institution. Each affiliated, independent, and contractor required Charter shall be free of the religious creed, beliefs, manifestations, doctrines, practices and or rituals chosen to adopt in forming A Non Profit Corporation.

ARTICLE XI- TRAINING CENTER FOR EDUCATION AND FINANCIAL EMPOWERMENT.

Visionist Center Outreach Global Ministries, Inc. shall develop strong relations with local churches, organizations, associations, and any Non Governmental Organizations to provide services and education in financial freedom from short term to long -term business partners for community growth and development further keeping good financial records and money management. To provide comprehensive financial education and Accounting services to businesses to manage their finances and help other consumers preparing their financial report and auditing the over all of the performance of their businesses and following the requirement of the law as set forth by the Internal Revenue Services. The purpose of this training Ministry is to be a leader that has the ability to

All training and services rendered in this ministry shall be governed by Statutes of Non Profit Corporation of the State of its jurisdiction and shall exercise in the course of it Tax-Exempt Status as provided by the Federal Law Statutes of the United States under the Internal Revenue Code of this present and any future Code regulated A Non Profit Corporation Religious Ministries as Tax-Exempt allowing and permitting this Corporation to better serve businesses within the maximum quality services donating as covered by the Federal Tax Exempt Status. The center shall provide:

1) Accounting Services also called the accounting process is a system that measures the activities of a business in financial terms. This accounting process shall perform the following functions:

1. Analyzing: looking at what happened and how the business was affected.
2. Recording: Putting the information into the accounting system.
3. Classifying: Grouping al the same activities (e.g., all purchases) together.
4. Summarizing: Totaling the results.
5. Reporting: Issuing the statements that tell the results of the previous functions.
6. Interpreting: Examining the statements to determine how the various pieces of information they contain relate to each other.
7. Communication: Providing the reports and financial statements to people who are

interested in the information, such as the business' decision makers, investors, creditors, and government agencies (e.g., the Internal Revenue Service).

2) Bookkeeping is the recording (record keeping) function of the accounting process; a bookkeeper enters the accounting information in the company's book.

3) Basic Computer Training for the new entry level those who are interesting in learning to further advance a career in the computer technology of today world.

4) Tax Professional School: preparing people of all ages to acquire the knowledge permitting them to enter the world of Tax Preparation to help themselves and others.

5) Immigration refugee Services: Providing Services to communities in the regions that have difficulties to afford the competitions and of individuals that cannot pay the price required at this center, all programs, services, and or products are provided to those in need that have financial burden for free or any contribution or donation as a gift and or freely done by a free mind and competent person. thereunto shall be subject to the Federal guidelines, rules, and laws that governed A Non Profit Corporation as a Tax- Exempt Status authorized participants, applicants, and customers to claim their contribution and donation and or gift made payable to this Corporation.

6) ESOL: This institution shall operate in a way to respond to humanitarian aid in time of crises assisting refugees of other countries as it shall permit by the law of the State in which it is established and also by the United States Federal Law guaranteed the due process for Immigrants and Non immigrants while seeking help to settle in the Land of Freedom and opportunity. Teaching English, history, US government and Branches, preparing immigrants to learn English to further understand the very core of this system

and how it does work. Credentialed and accreditation to be an agency that promoting diversity and security for equal opportunity. Shall it be the operation according to the United Nations Preamble that protected the international and global of individual civil right and privileges for survival.

Board of Directors: the power of this corporation shall be exercised, its properties controlled, and its affairs conducted by Board of Directors and such Board of Directors shall have the Incorporator as the Executive Chief in the making of decisions consistent to guarantee the functioning of each board member which shall follow the call to serve this corporation under the Incorporator Founder. The Board of Directors shall consist of not less than fifteen (15) persons. The number of Directors of the corporation shall be fifteen (15), provided however, that such number may be changed by a By-law duly adopted by the members.

The Directors named herein as the first Board of Directors shall hold office until the first meeting of members at which time an election of Directors shall be held in accordance with the by-laws at which point shall govern and preside by the Incorporator, who is the executive chief to choose, nominate, revoke, discharge, and replace if possible to safeguard the establishment of this Corporation. Directors elected at the first annual meeting, and at all times thereafter, shall serve for a term of one or more years as permitted by the By Laws and with a majority of vote supporting the fact of that continuity. Therefore, the initial Directors and or Trustees may be voted to continue the other terms before and after the expiration of the initial term ended. The initial officers shall consider elected for the first year until the annual meeting of members following the election of Directors and until qualification of the successors in office. Annual meetings shall be held at 2750 Somerset Drive Apt T104 Lauderdale Lakes, Florida 33311 on the 7th day of the year at 6:00 P.M., or at such other place or places as the Board of Directors may designate from time to time by resolution. Any action required or permitted to be taken by one Board of Directors under any provision of law may be taken with and or without a meeting, if all members of the Board shall individually or collectively consent in written to such action. Such written consent or consents shall be filed with the minutes of the proceedings of the Board, and any such action by written consent shall have same force and effect as it shall be taken by unanimous vote of the Directors. Any certificate or other document filed under any provision of law which relates to action so taken shall state that the action was taken by unanimous written consent of the Board of Directors without a meeting, and that the Articles of Incorporation and the By-Laws of this corporation authorized the Directors to so act. Such a statement shall be prima facie evidence of such authority.

ARTICLES XIII -EARNINGS AND ACTIVITIES OF CORPORATION

A. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, directors, officers, or other private persons, or entities, except that the corporation shall be authorized to pay reasonable compensation for services rendered and make payments and distributions in furtherance of the purposes set forth in Article X hereof:

B. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distributing of statements) any political campaign on behalf of any candidate for public office.

C. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income under section 501(c) (3) of the Internal Revenue Code of 1954/ 1986 (or the corresponding provision of any future United States Internal Revenue Law of (b) by a Corporation, contributions to which are deductible under section 170(c) (2) of the Internal Revenue Code of 1954 and /or 1986(or the corresponding provision of any future United States Internal Revenue Law.)

D. Notwithstanding any other provision of these Articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purpose of this corporation.

ARTICLE XIV- DISSOLUTION

Upon dissolution of the corporation, the board of Directors shall, after paying or making provision of the payment of all the liabilities of the corporation, dispose of the Corporation in such manner, or to such organization or organizations organized and operated exclusively for social, cultural educational, skill training, counseling, job placement, work orientation, assisting people with medical needs, humanitarian aid, assisting refugee in immigration issues, charitable, scientific, or religious purposes including in the mission statement as shall the time qualify as an exempt organization or organizations under Section 501(c) (3) of the Internal Revenue Code of 1954 and or 1986(or the corresponding provision of any future United States Internal Revenue Law), as the Board of Directors shall determine. Any such Assets not so disposed of shall be disposed of by the by a court of competent jurisdiction in the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations as such court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE XV -MEMBERSHIP

The qualification for members and the manner of their admission shall regulate by the Bylaws and Constitution of this Corporation.

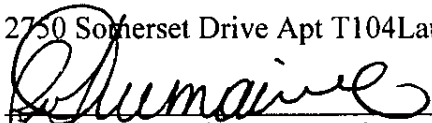

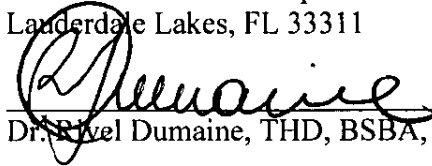
