Ocala Dance Force Parent Organization, Inc. exists to support the dancers of Ocala Dance Force Company, in Ocala, FL.

The Organization's mission is to foster an atmosphere of good sportsmanship; facilitate communications;

and financially and physically support the participation of all ODFC dancers at regional and national dance competitions and conventions/training.

The Ocala Dance Force Parent Organization, Inc. prohibits discrimination in all its programs and activities on the basis of

race, color, national origin, age, disability, and where applicable, sex, marital status, familial status, parental status, religion,

sexual orientation, genetic information, political beliefs, reprisals, or because all or part of an individual's income is derived

from any public assistance program.

No part of the net earnings of the Organization shall inure to the benefit of, or be distributable to its

members, trustees, officers, or other private persons, except that the Organization shall be authorized

and empowered to pay reasonable compensation for services rendered and to make payments and

distributions in furtherance of the purposes set forth in the purpose clause hereof.

No substantial part of the activities of the Organization shall be the carrying on of propaganda or otherwise

attempting to influence legislation, and the organization shall not participate in, or intervene in (including

the publishing and distribution of statements) any political campaign on behalf of any candidate for public office.

Notwithstanding any other provision of this document, the Organization shall not carry on any other activities

not permitted to be carried on by (a) an organization exempt from federal income tax under section

501(c)(7) of the Internal Revenue Code, or any corresponding section of any future tax code, or (b) by an

organization, contributions to which are deductible under section 170 (c)(2) of the Internal Revenue Code,

or any corresponding section of any future federal tax code.
