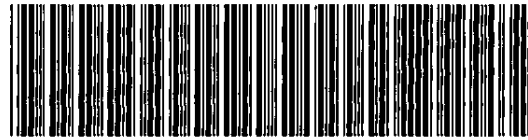

ARTICLES OF INCORPORATION

In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

The name of the corporation shall be:
She Can Learn, Inc.

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:
She Can Learn's mission currently is to raise the awareness about the education for children in Honduras. Currently, She Can Learn, Inc. raises funds to pay tuition for abused and abandoned girls at Our Little Roses home in San Pedro Sula, Honduras. She Can Learn, Inc. is exclusively for charitable purposes.

ARTICLE IV PROHIBITED ACTIVITIES

No part of the net earnings of She Can Learn, Inc. shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that She Can Learn, Inc. shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of She Can Learn, Inc. shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and She Can Learn, Inc. shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, She Can Learn, Inc. shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE V MANNER OF ELECTION
