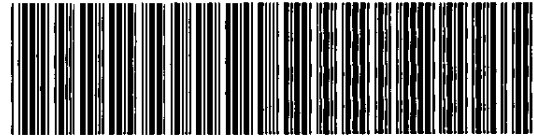

The undersigned do hereby associate for the purpose of becoming a not for profit corporation under the laws of the State of Florida, and do hereby certify that the following Articles of Incorporation have been adopted:

**ARTICLE I**

The name of the corporation is **SEWING FOR TEENS, INC.**

**ARTICLE II**

The street address of the initial registered office of this corporation is 5745 Benedict Road, Jacksonville Florida 32209 and the name of the initial registered agent at that address is Felicia A. Brimlett. The principal office address and mailing address of this corporation is 5745 Benedict Road, Jacksonville Florida 32209.

**ARTICLE III**

This corporation has the purpose or powers as may be stated in these articles of incorporation, and such additional purposes or powers as may be granted hereafter.

The primary purpose of this corporation is:

1. To help develop young minds by instilling integrity and independence through instruction that will give them a marketable skill.
2. To provide training classes to enrich the lives of teens by teaching them to use their creative knowledge while learning to sew. This instruction will be enhanced with group participation, random testing, cultural seminars, and a structured curriculum.

ARTICLE IV

The corporation shall have three (3) directors initially. The number of directors may be increased or decreased from time to time by majority vote of the association officers, but shall never be less than (3). The names and addresses of the first members of the Board of Directors who, subject to the provisions of these Articles of Incorporation, the Bylaws of this corporation and the laws of the State of Florida, shall hold office until their resignation, removal from office, or death, is as follows:

Any two or more offices may be held by the same person and directors may also be officers.

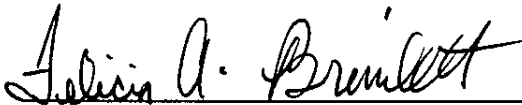
ARTICLE VII

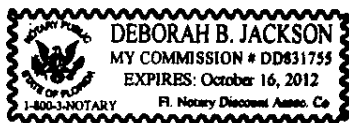
