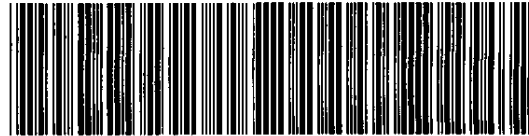

**ARTICLE I**

NAME

The name of the corporation shall be:

ANTIOCH BIBLE BAPTIST CHURCH, INC.

**ARTICLE II**

**ARTICLE III**

PURPOSE

The purpose for which the corporation is organized is to establish and maintain a regular church cooperating with the Missionary Program of the church, and to provide a place of Public Worship for the same in the city of Orange Park, County of Clay and the State of Florida.

To establish, maintain, and conduct for religious Instruction, Mission Churches, Mission Stations, and to further other religious, Educational and Charitable work to that end, adopt and establish bylaws and make all rules and regulations deemed necessary and expedient for the management of its affairs in accordance with the Law and not inconsistent with these Articles of Incorporation.

## **ARTICLE IV**

### **MANNER OF ELECTION OF DIRECTORS AND OFFICERS**

The manner in which the directors and officers are appointed or elected is as following:

The directors and officers are elected or appointed by the process of election and voted upon by a three-fourth (3/4) vote of the majority of the members of the Church present at a regular or special Business Meeting for such purpose to fill new offices or to re-elect ones to continue in a position of office.

The election of a pastor - director is to be presented by the pulpit committee and voted upon by the members present.

The dismissal of any director or officer will also be by a three-fourth (3/4) vote of the majority present for any conduct, rules, or regulation that miss represent the purpose and standard set forth by the Antioch Bible Baptist Church.
