ARTICLES OF INCORPORATION of REAL ESTATE LIVES, INC.

The undersigned subscriber to these Articles of Incorporation, a natural person competent TOUR MIG 20 PAN RO. 46 to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I - CORPORATE NAME

The name of the corporation is Real Estate Lives, Inc.

ARTICLE II - DURATION

The corporation shall exist perpetually unless dissolved according to Florida law.

ARTICLE III - PURPOSE
