Articles of Incorporation of

Greater Lake Worth Chamber of Commerce Education Foundation Inc.

This corporation is organized exclusively for one or more of the purposes as specified in Section 501(c)(3) of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code. This Corporation shall be a nonprofit corporation. The specific purpose for which this corporation is organized is Our mission is to raise private sector support to fund innovative and creative learning programs for the students.
