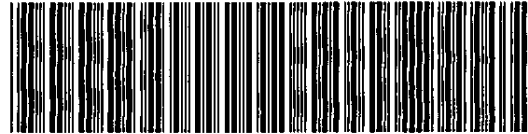

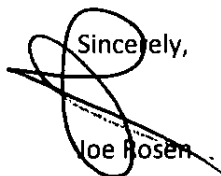

Article I – Name

The name of the Corporation shall be Temple of Tantra and Judaic Studies, Inc.

Article II – Principal Office

The principal place of business and mailing address of the Corporation is 1779 N. Congress Avenue, #211, Boynton Beach, Florida 33426.

Article III - Purpose

The specific purpose for which this Corporation is organized is to advance and promote the spiritual, physical healing, and personal development of individuals based upon an approach which is rooted in holistic thinking and traditional Judaism and Jewish concepts. The corporation will engage in a variety of activities for the purpose of fostering its holistic-oriented, Jewish based teachings, including, but not limited to, education, lectures, group meetings and discussions, healing circles, and through other modes of communication.

The Corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution or winding up of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

No substantial part of the activities of this Corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by Section 501(h) of the Internal Revenue Code), and this Corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.

No part of the net earnings of this Corporation shall inure to the benefit of, or be distributable to, its members, directors, officers, or other private persons, except that this Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these articles.

Notwithstanding any other provision of these articles, this Corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under

Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.

Article IV – Manner of Election

The manner in which the directors are to be elected or appointed shall be as stated in the bylaws of the Corporation.


Article V – Initial Registered Agent and Street Address

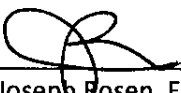
