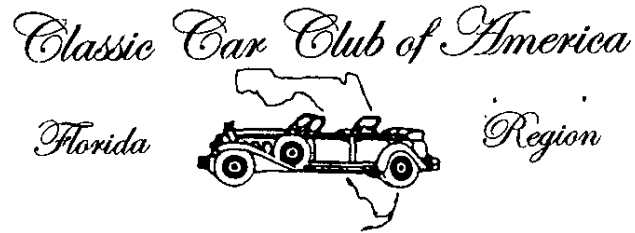

ARTICLES OF INCORPORATION

ARTICLE I NAME

The name of the corporation shall be: Florida Region CCCA, Inc.

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSE

The purpose for which the corporation is organized is to be a not for profit 501c7 social club for the furthering of the ideas and ideals of the Classic Car Club of America (CCCA) as reflected in the CCCA Bylaws in the Florida Region as defined and chartered by the CCCA on March 21, 1964 at Orlando, Florida; generally the north and central sections of the State of Florida, and to provide for regional activities for the National CCCA members living in that area. The CCCA was founded for the development, publication and interchange of technical, historical and other information for and among members and other persons who own or are interested in fine or unusual foreign or domestic motor cars built between and including 1925 and 1948, and distinguished for their respective fine design, high engineering standards and superior workmanship, and to promote social intercourse and fellowship among its members; and to maintain references upon and encourage the maintenance, restoration and preservation of all such Full Classic® cars.

ARTICLE IV MANNER OF ELECTION

The manner in which the directors are elected or appointed is in accordance of the Bylaws of the Florida Region CCCA where members of a Board of Managers are elected by the membership. Annually, the Board of Managers elects a Regional Director and Assistant Regional Director. The Regional director appoints, with the concurrence of the appointees. The Secretary and Treasurer of the Region.


