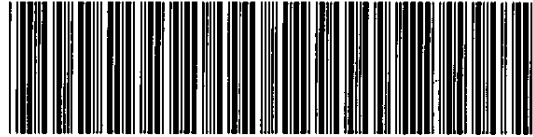

**ARTICLE 1 - NAME**

The name of the Corporation is **BRONSON COMMUNITY ACCESS CENTER INC.**, (hereinafter, "Corporation").

**ARTICLE 2 - PURPOSE OF CORPORATION**




