Article III Purpose

To operate and maintain community and family service centers mainly for the benefit of families having children of minor age who face dissolution of the family by divorce, separation, incarceration, natural disaster and the like, or who face foster care placement and/or the psychological, social, economic or emotional dysfunction that are attached to such family dissolution. In general, to guide and assist families towards the rehabilitation and stabilization of the family through study, evaluation, counseling, research and housing placement. The staging of demonstration programs and workshops designed to socialize and familiarize the parties with what it takes to achieve a stable family life.

In fulfillment and furtherance of the social, civic, cultural and educational objectives outlined above, the corporation shall seek to provide funds, such as necessary to engage the personnel, resources and facilities to carry the task, primarily by funding from governmental units, and contribution from the general public, or from a combination thereof.
